Name

Clause 1

- 1.1 The club shall be known as the Caldly Bowmen Archery Club, founded in 1968, and hereafter referred to as Caldly Bowmen.
- 1.2 The postal address shall be that of the Secretary or other address as required by the Committee from time to time.

Affiliation

Clause 2

- 2.1 Caldly Bowmen shall be affiliated to Archery GB each year. The officers are to ensure payment is made by the due date. If desired and determined by the members at a General Meeting, affiliation will be made to the NCAS, CAA and other bodies as so determined.

Objects

Clause 3

- 3.1 To promote and encourage archery in all forms apart from Bow-hunting and Crossbows.

Clause 4

- 4.1 The affairs of Caldly Bowmen shall be managed by the officers and Committee, who shall be elected at the Caldly Bowmen Annual General Meeting.
- 4.2 Only half the members of the Committee shall be available for re-election in one year at the AGM.
- 4.3 The Committee shall consist of:
 - a) Chairman (Captain)
 - b) Vice-Chairman (V. Captain)
 - c) Hon. Secretary
 - d) Hon. Treasurer
 - e) Records Officer
 - f) Five Committee members, including a representative for junior members
- 4.4 Six of the committee inclusive of 2 officers to form a quorum.
- 4.5 No individual may hold the Office of Chairman for a consecutive period of more than three years.
- 4.6 The Chairman shall cause the Committee to meet at least five times in any one year.
- 4.7 At the meetings of the Caldly Bowmen Committee the Chairman shall, if necessary,

be entitled to a casting vote.

Annual General Meeting

Clause 5

- 5.1 The Annual General Meeting of Caldý Bowmen shall be held before the start of each outdoor season.
- 5.2 No fewer than 28 clear days' notice of such meeting shall be sent to each member. Such notices will be deemed to have been served if delivered by the Secretary or posted to the last known address of the member or e-mailed to the last known e-mail address.
- 5.3 The Constitution of Caldý Bowmen shall not be altered or amended except at the Annual General meeting or an Extra-ordinary meeting.
- 5.4 Members wishing to move a proposition designed to alter or amend the Constitution shall submit such proposition to the Secretary 21 clear days before the General Meeting at which such proposition is to be considered.
- 5.5 Notice of such proposition shall be sent to all members entitled to receive notice of the meeting.
- 5.6 An Extraordinary General Meeting shall be called within 14 days of the signed request of not less than one-third of the members of Caldý Bowmen, forwarded to the Secretary and stating the nature of the business.
- 5.7 Nominations for Officers and Committee are to reach the Secretary 14 clear days before the Annual General Meeting. Agreement of the Nominee must be obtained and all nominations must be seconded. Nominations received after this date can be only accepted by a Committee quorum.
- 5.8 Each member shall have one vote. There will be no voting by proxy. The Chairman shall, if required, have a casting vote.
- 5.9 25% of the membership shall constitute a quorum and is required for any votes to be carried.
- 5.10 An auditor shall be appointed annually by the members in General Meeting. A copy of the Receipt and Payments, duly certified by the Auditor, shall be distributed before the Annual General Meeting to each Club Member.

Finance

Clause 6

- 6.1 The financial year to commence on 1st January and end on 31st December. The Committee shall cause to be prepared and shall present at the AGM, a balance sheet showing the financial position of Caldý Bowmen as at the 31st December of the preceding year, together with an income and expenditure account for the twelve months ending on that day.
- 6.2 No item of expenditure exceeding £800 may be made without the approval of a

quorum of the Committee. The Committee may not authorize the expenditure of any one amount exceeding £1000 without the majority approval of a General Meeting. This figure shall be reviewed at the AGM each year the exception being affiliation fees.

- 6.3 All classes of Annual Subscriptions shall be determined at the Caldys Bowmen Annual General Meeting and shall apply for the ensuing year. The subscription will include membership of Archery GB and other affiliations as determined but exclude shooting fees. Shooting fees for indoor and outdoor ranges will be charged separately. The Treasurer will recommend the amounts of such subscriptions to the meeting.
- 6.4 Shooting fees are due at the commencement of the outdoor and indoor seasons. A period of 30 days grace shall be given from the due date. Payments may be paid in two instalments at the discretion of the Committee.
- 6.5 The non-receipt of any subscriptions within 30 days of the due date will bar that member from shooting until such time as the subscription is duly received.
- 6.6 The one exception to the 30-day rule will be when more than one of the same household are members. A further 30 days grace will be given to enable payment of the subscription to be made in two equal instalments.
- 6.7 The Membership Secretary shall inform any member of an outstanding subscription after 30 days from the due date, that unless payment is made within a further 60 days membership of Caldys Bowmen will be deemed as having terminated.
- 6.8 Subscriptions are not refundable.

Membership

Clause 7

- 7.1 There will be the following classes of membership
 - (a) Senior
 - (b) Senior (18 – 24)
 - (c) Junior (to 18th birthday)
 - (d) Archer with Disabilities
 - (e) Honorary
 - (f) Associated
 - (g) Temporary
 - (h) Life
- 7.2 If Caldys Bowmen wishes to honour any person for services to Caldys Bowmen it may elect such a person as a Life Member at a general meeting. Nominations for such membership shall in the first place be made to the Secretary. If so elected, active archers are to be responsible for their own affiliation fees.
- 7.3 Associated and Temporary members are those of other Archery GB affiliated clubs

who wish to shoot with Caldys Bowmen either for a full season or on one day respectively.

- 7.4 Visitors must produce a current Archery GB membership card and pay the determined fee before shooting.
- 7.5 Junior members will only be accepted if accompanied by a parent, guardian or a responsible adult authorised by the junior member's parent or guardian, who undertakes to supervise the shooting (so far as it is practicable) and other behaviour of the junior.
- 7.6 Applications for membership must be submitted on the official membership form. All members shall accept the jurisdiction of Caldys Bowmen and shall conform to such conditions, shooting rules and regulations as may be determined from time to time.
- 7.7 If in the opinion of the Committee any member be deemed guilty of conduct which makes it undesirable that such member should continue with Caldys Bowmen, the Committee may, after affording such a member a reasonable opportunity to be heard, expel such a member from Caldys Bowmen. The Committee shall not be liable to state any reason for such a decision except to the member concerned and the decision is final, subject to any rights under the Archery GB constitution.
- 7.8 Beginners shall only be allowed to shoot in the presence of an experienced archer, to comply with Archery GB rules of insurance. An experienced archer shall be one who is a paid-up senior club member who has completed a recognized course of coaching/instruction in shooting.
- 7.9 This club believes that when dealing with children and vulnerable adults, their welfare should always be of paramount importance. We are committed to providing an environment where people can learn and participate in a sport free from harassment and abuse. All those people working with children and vulnerable adults have a moral responsibility to safeguard and promote their welfare. This club has therefore produced a safeguarding policy which, all members are to adhere to.
- 7.10 Beginners shall pay a fee, determined by the Committee, for the use of Caldys Bowmen equipment for a period of not more than six lessons. Beginners may, on joining the Club, have access to the equipment until such a time the equipment is required by the Club.

Shooting Facilities

Clause 8

- 8.1 Caldys Bowmen target days and venues will be announced to members at the beginning of each season. The Members' Handbook and the club website will be updated with the current information. All scores recorded on those days will be used for Handicap and Classification purposes.
- 8.2 In addition, it is the responsibility of each member to ensure all scores recorded at tournaments, visits, etc. be notified to the Records Officer.
- 8.3 Shooting is only permitted on the specified target days. At least two Senior Club Members must be present at all times.

- 8.4 Juniors may only shoot in the presence of at least two adults. This is to ensure the safeguarding of juniors and to protect adults.
- 8.5 Outdoor shooting location will normally only be changed by a majority vote at a general meeting. The Committee may seek to negotiate an alternative outdoor shooting location without referral to a general meeting, if it determines a better venue is available or the current venue notifies the committee of its intention to terminate the lease agreement. Indoor shooting venue will be decided by the Committee bearing in mind any recommendations made at a general meeting.
- 8.6 **Full carbon** arrows may only be used indoors and **must not be used outdoors** on the field as the arrows, if lost, may present a hazard to other persons using said field.

Club Trophies and Equipment

Clause 9

- 9.1 Caldys Bowmen Trophies shall at all times remain the property of Caldys Bowmen. In the event of the loss, damage or non-return by the last holder, the Committee will issue an invoice to the last holder to cover the loss/repair of trophies.
- 9.2 The property and assets of Caldys Bowmen shall be vested in the Officers and Committee for the time being. The Committee shall be responsible for the management and control of such property and assets.

Dissolution

Clause 10

- 10.1 Should Caldys Bowmen cease to exist for any reason whatsoever all funds, trophies and other properties remaining shall be handed over to Archery GB to be dealt with as necessary.

Clause 11

- 11.1 Discretionary power is given to the committee to decide any circumstances not covered by these rules.
- 11.2 In cases of emergency the Chairman (or Vice Chairman), Secretary and Treasurer will have full powers to act in any way deemed to be in the best interest of Caldys Bowmen.
